Education, CGFM & Scholarships

In addition to the 10 CPE hours offered via the monthly luncheons, the Chapter was able to offer 6 more CPE hours by hosting three 2-hour audio conferences in conjunction with the luncheons. The audio conference topics included:

- Data Mining to Prioritize Investigations of Contract Fraud (Bryan Jones, Director of Data Mining Group, Office of Investigations, Office of the Inspector General, U.S. Postal Service; and Antonia de Medinaceli, Director of Business Analytics & Fraud Detection, Elder Research, Inc.), presented after the November 2012 luncheon;
- Getting a Handle on Internal Controls (William D. Miller, CGFM, CIA, County Auditor, Johnson County, Kansas and Member, AGA National Executive Committee), presented after the January 2013 luncheon;
- Using Performance Information to Drive Performance Improvement (Harold I. Steinberg, CGFM, CPA, Consultant; and Toni Trombecky, Performance Improvement Officer and Manager, Strategic Planning Division, Federal Aviation Administration), presented after the May 2013 luncheon.

Collectively, the luncheons and audio conferences provided attendees with an opportunity to earn up to 16 CPE hours.

Luncheons

The Chapter was successful in recruiting speakers for nine luncheon presentations. These engagements provided members and guests an opportunity to earn a total of 10 CPE hours. The speakers for those events include the following:

September 2012: **Dr. Urton Anderson**, CIA, CCSA, CGAP, CFSA, CCEP, a Clark W. Thompson Jr. Professor in Accounting Education at the McCombs School of Business, University of Texas at Austin, discussed the Dodd-Frank Wall Street Reform & Consumer Protection Act, the JOBS Act of 2012 and Developments in the SEC and Financial Market Regulation.

October 2012: **Philip Ashley**, CPA, CGFM, Director of Fiscal Management, Comptroller of Public Accounts, presented on the need for government financial reporting transparency and how citizen-centric reporting can improve communications between government and its taxpayers.

Dr. Carolyn Conn and Members of the St. Edward's University finalist team, in the AGA Graduate Finance Case Challenge (placing in the top three), including **Leigh Anne Floyd, Sandra Hernandez, Cynthia Wainwright-Branigan, and Maura Valle**; discussed their experience regarding their project, a Citizen-Centric Report for the City of San Diego, by demonstrating an innovative and creative means of communicating the City of San Diego's financial information to its citizenry using the Citizen-Centric Report format.

November 2012: **Evelyn Brown**, CGFM-Retired, AGA 2012-2013 National President, presented on the topic "Our Professional Journey" and shared her insight on how to acquire adequate skill sets for career development; plotting goals and objectives at different levels in a career path; and the importance of being flexible in your career path.

December 2012: Paul Morris, CPA, CIA, Director of Internal Audit, Texas Department of Family and Protective Services, presented on the topic of "Identity Theft-Corporate Risks and Control," and discussed common risks to data, controls that can minimize the risk to client and employee data, and the roles of auditors in an entity's overall privacy framework.

January 2013: **Dr. Dwight D. Daniel**, Director, MS in Computer Information Systems, School of

Management and Business, St. Edward's University, presented on the topic of "Cloud Computing- Who Cares" and discussed security issues related to Cloud Computing.

February 2013: **Paul Priest**, Assistant Director of the Texas Legislative Budget Board (LBB), provided attendees with an understanding of the Texas State Legislative Process used by state agencies and institutions of higher education; why enacting a budget is important; the rules of the game; and how the budget is relevant to state agencies and its staff and consumers.

March 2013: **Tonda Hadley**, CPA, CGFM, Director of the Central Regional Office for the Office of Emergency Management Oversight, under the Office of Inspector General, U.S. Department of Homeland Security, discussed the Capping Report on FY 12 Audits of FEMA Disaster Grants and the difficulties auditors face when auditing disaster grants.

April 2013: **Dade Dowdle**, HORNE, LLP, presented on the topic of "Equipping Local Jurisdictions for Disaster Recovery Program Compliance" and discussed the changes to the guidelines governing FEMA's Public Assistance program between recent disasters affecting Texas, and how to equip decision-makers and record-keepers with knowledge to avoid common pitfalls noted in regulatory compliance reviews in Texas.

May 2013: Holly Brewster, Procurement Consultant to Department of Family & Protective Services, discussed procurement risks, and the role and importance of government accountability professionals in the purchase of goods and services by government entities.

Monthly attendance at the meetings averaged **27**, which is a 27% decrease from 2011-12 attendance numbers. An attendance breakdown by luncheon follows:

Minutes and Treasury Reports

Mari Queller expertly and diligently carried out her duties as Treasurer. To help her complete her task more efficiently, Mari utilized a Square Credit Card reader to process payments via her iPad or iPhone. The Chapter began the year with a cash balance of \$8,700.14 and ended the year with a balance of \$7,945.30. Mari was also instrumental in getting the Chapter's name officially changed to Association of Government Accountants- Austin and established our exempt filing status with the IRS. In addition, Mari updated the Chapter's Tax Exempt EIN with the Texas Comptroller of Public Accounts Office (CPA) to reflect our own and not National's EIN. Lastly, Mari set up an account for AGA Austin with the CPA Windows on State Government, Vendor Account Search webpage and queried our ACH deposits/warrants. As a result, the Chapter now has a nice report available to print regarding our transaction history, for which the Chapter Treasurer will have continuous access to and will be able to run from the CPA website at any time.

Research Article

The Journey Continues

Since 1996, the Association of Government Accountants (AGA) and Grant Thornton LLP have jointly sponsored an annual survey of government chief financial officers (CFOs). In 2009, the National Association of State Auditors, Comptrollers and Treasurers (NASACT) joined the effort to understand the current issues facing government financial executives, expanding the survey to state financial managers. The goal of the annual survey is to provide relevant thought leadership and resources, as well as a vehicle for practitioners to share their views and experiences with colleagues and policy makers.

Given the recent pace of fiscal austerity measures, new mandates, and major shifts in our healthcare system, the survey represents a good time to stop and assess current financial capability, risks, and the ability to adapt. The survey results indicate that there is much good work in progress in response to these challenges, but it also shows that there is room for improvement going forward in the strategic approach to solving them.

According to the survey, in order for finance offices to continue to provide value to state and local governments, a variety of pressing needs must be met. In response to the ever-present personnel, funding, and technology challenges, these financial leaders require innovative approaches to practical workforce management. They also have an increasing need for more analytic staff to mine large amounts of financial data and present effective, actionable options to decision makers. And finally, they need timely and responsive tools and solutions that optimize leading-edge technology.

Other findings include:

- Clean financial audit opinions are an area of high confidence, with over 88 percent of respondents reporting a clean audit opinion.
- Most executives believe that agency program managers see benefit in the financial statement audit.
- About half of respondents have expanded the scope of their internal control programs to include operational and/or programmatic risk.

Many respondents accomplish cost cutting through across-the-board methods even though they realize this is not effective.
